The Ministry of Education, Youth and Sports of the Czech Republic will in 2024 grant for Greek citizens three (3) scholarships for participation in the Summer Schools of Slavonic Studies 2024, in compliance with Article 5b) of the Programme of Educational and Cultural Co-operation between the Government of the Czech Republic and the Government of the Hellenic Republic for the years 2010-2013 (the effect of which has been automatically prolonged until a new programme for the next period is signed). The scholarships for Greek citizens will be granted specifically for the Summer Schools of Slavonic Studies 2024 to be held 1) Faculty of Arts, Charles University in Prague (one/1 scholarship), 2) at the Faculty of Arts of Masaryk University in Brno (one/1 scholarship) and 3) at the Faculty of Arts of Palacky University in Olomouc (one/1 scholarship).

# Detailed information on scholarships for Greek citizens to participate in the Summer Schools of Slavonic Studies in the Czech Republic in 2024 and Instructions how to apply

Three (3) scholarships will be granted for Greek citizens to participate in the Summer Schools of Slavonic Studies in the Czech Republic in 2024, in compliance with Article 5b) of the Programme of Educational and Cultural Co-operation between the Government of the Czech Republic and the Government of the Hellenic Republic.

Detailed information about the Summer Schools of Slavonic Studies (SSSS) and the application form are available on the website of the Ministry of Education, Youth and Sports (MEYS) Summer Schools of Slavonic Studies 2024, M§MT CR (msmt.cz)

- A) One scholarship has been assigned for the Summer School of Slavonic Languages at the Faculty of Arts of Charles University in Prague the course will be held from 18th July 15th August 2024, detailed information can be found on: L§SS onsite I LSSS (cuni.cz).
- B) The second scholarship has been assigned for the Summer School of Slavonic Studies at the Faculty of Arts of Masaryk University in Brno the course will be held from 20th July 17th August 2024, detailed information can be found on: Summer School of Slavonic (Czech) Studies I Department of Czech for Foreigners (muni.cz).
- C) The third scholarship has been assigned for the Summer School of Slavonic Studies at the Faculty of Arts of Palacky University in Olomouc the course will be held from 13th July 11th August 2024, detailed information can be found on: LSSS (upol.cz)

Greek citizens can apply only for the courses organized at the three aforementioned universities. Only those who will have completed 18 years on the 1<sup>st</sup> day of the course can apply.

The scholarship covers tuition, board, accommodation and excursions organised as part of the respective summer school course programme.

Medical care for EU/EEA citizens who are properly insured in their home countries is provided in compliance with the European Parliament and Council (EC) Regulation No. 883/2004, as last amended, and its implementing Regulation No. 987/2009, as amended by Regulation No. 465/2012 - detailed information is available on the website of the Health Insurance Bureau. Please note that the expenses for repatriation are not covered by the provisions of the aforementioned European Regulations, and it is therefore advisable to obtain an insurance policy to this end even if you come from an EU/EEA country. The Embassy kindly asks the esteemed Ministry to inform the candidates and the alternates in detail on the health care service coverage terms in this respect.

It is further recommended to submit also applications of potential alternates - the number of potential alternates might be twice as much as the official candidates are.

Apart from candidates nominated officially as scholarship applicants by the Greek authorities under the principle of reciprocity, other citizens are also encouraged to apply for the summer school courses - these apply directly to the respective schools and cover the course expenses themselves. The Embassy of the Czech Republic encloses short information about all Summer Courses of Slavonic Studies that will take place in the Czech Republic in the year 2023, including the appropriate contact details. #### 5. IMPORTANT NOTICE

The Slimmer Schools of Slavonic Studies offering Czech language courses are organised by several public universities in the Czech Republic: Charles University (Faculty of Arts, Prague), Charles University Institute for Language and Preparatory Studies in Podebrady. Masaryk University (Faculty of Arts, Brno), Palacky University in Olomouc (Faculty of Arts, Olomouc), University of South Bohemia in Ceske Budejovice (Faculty of Arts, Ceske Budejovice) and the University of West Bohemia in Pilsen. The courses are held during the summer months (July - September), their length ranges from 3 to 4 weeks depending on the course content determined by each Summer School and are designed for foreign students, teachers, translators and interpreters and other experts active in the field of Czech/Slavonic studies. Due to their broad scope they are, however, open to anyone else who is interested in the Czech language, literature, history and culture. The Summer Schools offer language courses at various levels of proficiency, seminars on the Czech literature, culture and history, free-time activities including theatrical, musical and dance performances, trips etc.

**Period of Scholarship and Benefits:** The scholarship is provided in the form of free board and lodging, coverage of course fees (tuition and registration fee) and other services which are an integral part of the course programme. A scholarship holder will be provided with free board, lodging and other services covered by the scholarship only during the period of course offered by the respective Summer School.

**Health insurance** is NOT provided to scholarship-holders, who are advised to arrange a medical insurance policy for the period of their stay in the Czech Republic. More information can be provided by the consular section of the Czech Embassy in your country; EU/EEA medical insurance system is described on the website of the Health Insurance Bureau,

**Visa -** Information on the conditions of entry and residence of foreign nationals in the Czech Republic is available on the <u>website</u> of the Ministry of Foreign Affairs of the Czech Republic.

A scholarship holder is obliged, once he/she receives information on acceptance, to confirm his/her attendance at the Summer School by sending a message to the contact e-mail <a href="mailto:posta@msmt.cz">posta@msmt.cz</a> and/or to the relevant contact at the Summer School (see below). If an admitted scholarship-holder cannot attend the Summer School concerned, he/she is obliged to inform the relevant contact person at the Summer School immediately.
